Over the past while, I have been reading and studying the ELCA Congregational Leader Series. This series of nine books focuses on the ministry work of leading and being a member in Christ's Church/Holy Cross Lutheran Church.

We begin a New Year—with exciting and challenging Ministry work before us: Worship, Learning, Fellowship, Service, Outreach and Administration. We also welcome our new Pastor, Pastor Kathy Morris to worship and work with us. She will walk and work among us, preaching and teaching the Word of God, providing leadership in worship, pastoral care and speaking for justice on behalf of the poor and oppressed.

As I prepare for the coming year, I have found much support and learning from this Congregational Leader Series. A few highlights from the Series Overview!

"We are all ministers!—everything we do and plan is communal. We cannot plan unilaterally or devise strategies in isolation. In baptism we are united with the body of Christ, and the gifts that God has given each of us are meant for the common good of all God's people: "To each is given the manifestation of the Spirit for the common good" (1 Corinthians 12:7)"

"With that foundation, we recognize that Congregations are complex! The congregation embodies three different organizations at the same time: A community of spiritual formation, a voluntary association and a nonprofit organization!"

Continued from previous page ~ from Council President, Diane Torry:

"As a community of spiritual formation, we are a people coming together in community to join with others in growing closer to God—seeking to understand God's word and God's will for our lives. Through worship, learning and education, supporting all our brothers and sisters in times of crisis and need, engaging in visible activities, supporting those who are hungry, homeless, hurting. There is no room for pretense, no room for manipulation, no room for power games."

"As a voluntary association, we voluntarily gather together and form relationships with those with whom we have much in common. People want and expect to be contacted regularly by both leaders and other members, and to feel that they are fully accepted as part of the group. Leaders must pay particular attention to involving the widest possible participation of members in planning and setting goals so that the central focus is not lost."

"As a non-profit organization, we are chartered, incorporated, and recognized as a legal entity by the federal, state and municipal government. We as a congregation are accountable to society and responsible for following all applicable laws. The congregation has formal operational procedures and documents (from our constitution) that direct how we must make decisions and conduct our affairs. This helps make sure that our congregation will make the best use of our resources in furthering our mission to be Christ's Church."

"The entire series seeks to build on the positive, basing our planning on assets rather than deficiencies, and to focus on outcomes, enabling our congregation to make a specific and definable difference in people's lives. Faithful planning and leadership development takes us on a journey, a pilgrimage, and an exploration of God's possibilities for our congregation. The Congregational Leader Series provides resources for our travels as we seek God's will and guidance for us individually and as a congregation ".

I look forward to worshiping, learning and working with all during the coming year "We are Church Together".

Holy Cross Annual Congregational Meeting Set for January 27

On Sunday, January 27, we will have only one worship service at 9:00 a.m. so that the Annual Congregational Meeting may follow at 10:30 a.m. All formal church members as well as interested regular worshipers are encouraged to attend to be well-informed and for members to participate in decision-making. As a congregation, Holy Cross is led by its Council, which is its governing board responsible for the general oversight of the life and activities of the church. Authority to make certain decisions, such as approving an annual budget or electing members of the council, is vested with the congregation itself and voting takes place at this meeting.

Holy Cross supports a number of local agencies that help us to continually renew our Christian promise to help those in need--to feed the hungry, shelter the homeless, clothe the naked and comfort the weary and outcast and welcome the stranger and to be a loving neighbor to all people of the earth.

Here is information about a number of agencies supported by gifts from our Holy Cross family--connecting to their websites will give you more information about the good work that these agencies do in our community and around the world.

<u>Shared Harvest</u> ~ Working with four other Lutheran Congregations in Reno Sparks, food items are collected and distributed each month to families living in 4th street motels. Needed food items are published in the Bulletin each week. Leave your donations on the Shared Harvest table in the Fellowship Hall.

<u>Good Shepherd's Clothes Closet</u> ~ You can donate your gently used clothing to this agency that works with over 100 local agencies provides free clothing to those in need in our community. The collection container is under the Shared Harvest table in the Fellowship Hall. <u>www.gscreno.org</u>

<u>Veterans Hospital, Community Living Center</u> ~ Annually, quilts and afghans made by the Quilt Group and Hooks and Needles are given to Veterans in long term care. <u>www.reno.va.gov</u>

Ronald McDonald House ~ Several times a year the Service and Fellowship Committee arranges an evening meal for families staying at the Ronald McDonald House, which provides housing and support for families with children in our local hospitals (look for announcements in the weekly bulletin). <u>Lutheran World Relief</u> ~ Quilts completed by the quilt group are donated each fall. These quilts are sent to our brothers and sisters in need around the world.

Everyone is welcome to join our quilt group. No quilting or sewing experience is required. Although experienced quilters and seamstress are also treasured. During our quilt meetings we do a variety of things, cutting fabric, sewing quilt tops, pressing the material, designing tops, coordinating tops and backs and tying the quilts.


We meet in the Fellowship Hall the first and third Thursday of each month at 9:30 a.m. and 1:00 p.m.

Thank you again to our wonderful congregation for all your support in 2018. It's YOU that makes our outreach programs so successful!




Holy Cross Usher News....

Please consider a gift to the New Pastor Fund to pay for these expenses. Thank You!


